

## Complex Cases in Difficult Venues

King & Spalding's lawyers have tried cases in the most challenging venues in the United States, including California, Illinois, Louisiana, Texas and West Virginia. They defend individual claims, class actions, mass joinders and multi-district litigation brought by workers, property owners, riparian owners, members of the public and product end users.

In the past five years, the firm has defeated more than 16 class actions, resolved large dockets of tort cases and tried multiple cases to defense verdicts. The following are examples of recent cases:

- Represent **Halliburton Energy Services, Inc.**, in a putative class action and 14 separate mass joinder and individual lawsuits pending in federal court in Oklahoma. Plaintiffs asserted claims for personal injuries, property damage, medical monitoring and remediation due to groundwater contamination. The firm obtained early dismissals of plaintiffs' medical monitoring and RCRA claims.
- After a four-month trial, obtained a complete defense verdict on behalf of **The Dow Chemical Company** in San Francisco Superior Court. Plaintiffs alleged that exposure to 1,2,3-trichloropropane and 1,2-dichloropropene in soil fumigants had caused a cluster of sarcoidosis cases and a wrongful death from testicular cancer.
- Obtained a complete defense verdict for **Shell Oil Company** in litigation alleging that the city of Redlands' drinking water had been contaminated with 1,2,3-trichloropropane. The city had sought \$46 million in damages.
- Represented **Lincoln Electric Co.** and other manufacturers or distributors of welding products in trials involving allegations that the plaintiffs were harmed by inhaling manganese particles in welding fumes. Tried several cases to complete defense verdicts.
- Represent **The Dow Chemical Company** as national counsel for chlorinated products litigation. In that role we have represented Dow in numerous claims by municipalities, redevelopment agencies and water purveyors claiming contamination of sites and groundwater by perchloroethylene ("PCE"), trichloroethylene ("TCE") and related compounds.
- Represent **Beazer Homes USA, Inc.**, as national coordinating counsel in the Chinese Drywall Litigation.
- Represent **Chevron U.S.A.** in securing dismissal of a putative class action in which plaintiffs sought to hold Chevron and other oil and gas companies liable for personal and property damages caused by Hurricanes Katrina and Rita.
- Represented **Union Carbide Corporation** as national coordinating counsel in individual and class action litigation in 19 states involving tort, fraud and conspiracy claims arising from alleged exposure to vinyl chloride.
- Have served as national coordinating counsel, regional counsel and local trial counsel for numerous clients facing the never-ending challenge of asbestos litigation. Our representative clients include **General Motors, Ford, Honeywell, Chevron, American Cyanamid Company, Fiberite, Hewlett-Packard, National Service Industries** and **AkzoNobel**. For a large paper and building products company, we serve as national counsel on asbestos expert discovery issues, including taking the lead in briefing and argument on Daubert and Frye issues in asbestos cases across the country.
