

# Coordinated Guidance through Complex Corruption Investigations

Corruption issues are often intertwined with a range of other legal concerns involving many different stakeholders. We work together across practice groups and industries—one area of expertise informing another—to provide you with cost-effective, informed, and well-coordinated counsel.

### U.S. Department of Justice

The DOJ Criminal Division in Washington and 93 U.S. Attorneys' Offices around the country investigate and prosecute violations of the FCPA and can impose severe penalties, including jail time, fines, and corporate monitors.

Our team understands DOJ's enforcement priorities and processes from having worked there. Many of us are former prosecutors and investigators, including recent leadership from the DOJ's FCPA unit.

### U.S. Congress

High-profile investigations can lead to inquiries from Congressional investigative committees. Congress continues to debate whether the statute should be amended, perhaps to include a compliance defense.

We have extensive experience both conducting Congressional investigations and representing clients before Congressional investigative committees, and can assist you through these complicated and often intense inquiries.



The SEC is responsible for civil enforcement of the FCPA, and its jurisdiction includes non-U.S. companies whose shares are traded in the U.S. Its whistleblower program provides significant monetary awards to eligible whistleblowers.

Our team includes practitioners with extensive SEC enforcement experience—including former senior SEC officials—who know the SEC's expectations and how to meet them.

### O U.S. Law Enforcement Agents

The DOJ works with the FBI and other agencies to investigate international corruption. The Department of Homeland Security also has broad authority to investigate cross-border financial crimes, and the IRS has jurisdiction over tax, money laundering, and bank secrecy laws.

We know how to work with agents and investigators in a variety of federal agencies—particularly those that deal with corruption-related crimes.

### O Foreign Authorities

Myriad foreign enforcement agencies enforce local anti-corruption laws. The OECD requires member countries to enact and enforce bribery laws. Multilateral investment banks investigate corruption and suspend or debar offending companies.

We are experienced with the foreign local anticorruption laws—such as the UK Bribery Act, the French "Sapin II" law, and the Brazil Clean Companies Act—and how to coordinate issues with the foreign agencies that enforce them.

### **Shareholders**


Shareholders of companies under investigation may bring class action suits that allege and seek damages attributed to management corruption, fraud, negligence, and malfeasance.

We run investigations designed to identify improper conduct while protecting investigative findings to limit harm imposed by related shareholder class action suits.

# Departments of Commerce, State, and Treasury

Commerce lists foreign public bribery as a trade barrier and encourages reporting. State engages with U.S. companies doing business overseas to combat corruption and bribery. Treasury administers and enforces economic and trade sanctions.

When necessary, we manage interactions with these government departments whose activities—such as economic and trade sanctions—often intersect with anti-corruption issues.


