Prior to the 2014 election, she counselled a southern state on compliance with the requirements of the Voting Rights Act.

Prior to entering private practice, Ms. Hrvatin served for five years on Capitol Hill, most recently as Legislative Director to Representative Chris Cannon of Utah. As chief policy advisor to Representative Cannon, she handled both his Judiciary Committee and Science Committee posts, advising specifically on the areas of aeronautics, immigration, intellectual property and technology, as well as on an array of other issues, including appropriations, health care, parliamentary procedure and tax.
