His leadership as California's "Top Cop" resulted in a crime drop of 30% with a homicide drop of 50%. Dan successfully argued a case before the U.S. Supreme Court.

Dan is a graduate of the University of Notre Dame, attended law school at the University of Southern California and graduated from Georgetown University Law Center with his J.D.
