Lloyd Hand is a senior counsel in King & Spalding's Government Advocacy practice. Among other duties, he was responsible for the company's external relations worldwide, including the company's government affairs office in Washington, D.C. Prior to becoming an officer of the company, Lloyd served as outside counsel, advising and assisting TRW to enter foreign markets to achieve investment and operating objectives.

In 1984, Lloyd became a senior partner at Verner, Liipfert, Bernhard, McPherson and Hand. The firm later merged into DLA Piper LLP, where he remained until joining King & Spalding.

Lloyd served as a member of the Senior Advisory Group (SAG) to the U.S. European Command, and formerly served on the Chief of Naval Operations Executive Panel. He holds a T.S./S.C.I. security clearance.
